## Summary: Key Strategic Developments 2019

#### This year we had three goals:

- Increase the size of the community of conformance
- Increase the size of the partner program
- Build out activities in China, Japan, Korea and India

#### We had success in all of these areas:

- The community of conformance has increased from 20 to 35 entities
- The partner program has more than doubled to 21 entities
- We have work groups in China, Japan, Korea, India and Taiwan

- We had significant progress on our ISO preparation




## OpenChain in ISO (June 2019~)




The OpenChain Project is submitting our specification to ISO via Publicly Available Specification (PAS) in Joint Technical Committee 1 (JTC-1).
